

Dear Madam,

In reply to your communication of 3rd instant, I have to state the only information received at this Office to date regarding No. 5028, L/Cpl. M. G. Allan, 32nd Battalion, is that contained in the brief cable message - Killed in action, 20/5/17. Later official advice coming to hand giving further details will, on receipt, be promptly communicated to you. A certificate of report of death in this case will be forwarded when the necessary confirming documents are received from abroad.

I have no notification of a Will of this soldier to date. If L/Cpl. Allan has prepared the Will-form provided in his pay-book, or if such a document be discovered amongst his personal belongings, the Authorities at the Front will despatch same to this Office for transmission to the Legatee.
