

Service No. 3195 Private 27th Battalion

Born 13 April 1892 at Nailsworth, South Australia Son of Jesse LAMPIT (dec) & Jane Ann nee SMITH Of Pulsford Road, Prospect, SA Enlisted 17 August 1915 Served in Egypt, Belgium and France Killed in action in France 05 November 1916

A 23 year old labourer prior to enlisting in the AIF on 9 August 1915, he embarked for overseas with the 7th Reinforcements from Adelaide on 12 January 1916 aboard HMAT Medic. While serving on the Western Front, he was killed in action on 5 November 1916 near Dernancourt, France and his name is inscribed on the Villers-Bretonneux Memorial with others who have no known grave.
