However, is you state you did not receive the advice some mistake has apparently occurred in the delivery of the wire.

Your change of address has now been noted, and any later cabled report coming to hand will be promptly communicated to you, but in the absence of same favorable progress may be assumed, the practice of the overseas authorities being to notify this Office of any serious change in a soldier's condition.
